## **CONFIDENTIALITY POLICY**

This policy exists to provide guidelines for how and when the Biblical Counselor shares detailed, personal information provided by counselees about their life situation.

We seek for all communication between counselee, pastor, and/or Biblical Counselor to be held in strict confidence, unless the counselee, or a parent in the case of a minor, gives authorization to release this information. As policy, counselors are strongly persuaded not to disclose personal information to others. Counselors will make every effort to help counselees to resolve problems as privately and confidential as possible.

## **External Communication**

In order to protect counselee, counselor, the church and others who may be affected by a particular counseling situation, we seek to abide by the following exceptions to this confidentiality policy:

- If a person expresses intent to harm themselves or someone else a counselor may alert the authorities as deemed necessary at the time.
- If there is evidence or reasonable suspicion of abuse against a minor child, elderly person, or dependent adult a counselor may alert the authorities as deemed necessary at the time.
- If a subpoena or other court order is received directing the disclosure of information, the Biblical Counselor or Summit Point Church staff will work with the authorities in order to comply with the law.

## **Internal Communication**

Internal communication of detailed, sensitive, personal information shared by the counselee is only for the purpose of helping the counselee in their situation.

We believe that the concept of total confidentiality is not biblical. However, information regarding a counselee and their situation will be handled with the highest possible level of discretion. Carefully discerning how to share information is an important aspect of the Biblical Counseling relationship and we will carefully guard any information entrusted to us. *When it is deemed necessary, a counselor may:* 

- Discuss case with Biblical Counseling Pastor staff, elders of SPC, the advocates, as well as with previous counselors or other lay leaders currently involved in the care process. These discussions will be conducted for the sole purpose of gaining information for the counselee's care or to help in follow-up and aftercare. Only the most pertinent information will be shared on a "need to know" basis.
- Seek the assistance of others in the church to encourage repentance, restoration, and reconciliation [see Proverbs 15:22, 24:11, Matthew 18:15-20 and SPC's church discipline policy] due to a person's persistent refusal to renounce a particular sin [habitual unrepentant rebellion against the Word of God].
